**1. IMPORTANT INSTRUCTIONS:**

- Online Applications are invited from intending candidates to fill up 6(six) numbers of posts of Weaving Supervisors under Handlooms, Textiles & Handicrafts Department, Government of Odisha as initial appointee.

- Candidates must register their valid e-Mail Id and Mobile number while applying for the post and keep the same active till completion of this recruitment process to receive important messages from the Commission relating to the recruitment.
- Before applying for the post, the Candidates must go through this advertisement uploaded in the official website of the Commission and on satisfying the eligibility criteria prescribed may apply for the post through online mode only. Application(s) received through any other mode shall not be entertained/received by the Commission.
- Candidates must have passed Diploma in Handloom Technology/ Textile Technology from IIHT or other Government recognized Institutions as on the last date of submission of online application form and must possess requisite certificate of passing HSC or ME standard in Odia as a Language subject are eligible to apply for the post.
- The appointment will be as Initial Appointee carrying a consolidated remuneration of Rs.25300/- per month (for 1<sup>st</sup> year) as per Odisha Group-B Posts (Contractual Appointment) Amendment Rules, 2017 notified vide Government in GA & PG Department Notification No. GAD-SC-Rules-0037-2017-19569/Gen dtd.12<sup>th</sup> September, 2017 & Notification No.28626/Gen dtd.27.10.2021.
- Candidate to be eligible to apply for the post (refer to Clause-6(a) of this Advertisement) may claim usual age relaxation only in case of PwD/ In-Service (Contractual employees) /Ex-Servicemen candidates as per relevant rules of Govt. of Odisha in force.
- In-service contractual candidates appointed before 17.01.2014 in Group-B post/services & before 18.11.2013 in Group-C posts/services & claiming benefits under the Contractual Appointment Rules shall have to follow the advisory notice published vide No.3568/ dtd.01.11.2019 available in the Commission's website.

- Commission will adopt normalization process for processing the result where candidates appear the examination through CBRE(Computer Based Recruitment Examination) mode in multiple batches using different sets of question papers so as to offset the difficulty level that may arise in such use of multiple set of question papers in the said examination.
- The candidate must submit correct data /information in the Online Application Form basing on which he/she shall be allowed to appear the examination. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria prescribed for the post, his/her candidature for the post will be cancelled forthwith.

## 2. How to apply:

- The applicants have to go through the Detail Advertisement before filling up the online application form.
- Aspirants have to apply online using the official website of the Commission [www.ossce.gov.in](http://www.ossce.gov.in).
- All eligible candidates have to register themselves by clicking on “**APPLY ONLINE**” button in the Home page of the Commission’s website [www.ossce.gov.in](http://www.ossce.gov.in).
- Those candidates who are applying for the first time have to register for the post by clicking on “**NEW USER**” button shown on the screen. On submitting the registration form a User Id and Password will be generated.
- On clicking “New user” or “Registered User” instruction for filling up the Online Registration/ Re-registration and Application Forms shall appear on the computer screen. These instructions are to be read carefully before proceeding for filling up the Application Form.
- Step by step procedure for registration/re-registration can be viewed by clicking on “**Instruction to fill up Online Application Form**”.


## 3. Pre-requisites for filling up Online Application Form

- Applicants should possess and maintain an e-Mail Id and Mobile Number for accessing the OSSC web portal and to make Online Registration/Re-Registration and Application Form. **Candidates should keep that e-mail Id and Mobile Number (given during registration) active for all important communication till publication of the final result of this recruitment exam.**
- Recent Passport size Colour Photograph of the Applicant, scanned in “jpg/jpeg” format between ranges of 20 kb to 100kb shall be kept handy for uploading during Registration for any post.
- Full Specimen Signature & Left /Right Thumb Impression of the Applicant, scanned in “jpg/jpeg” format between ranges of 20 kb to 50kb shall be kept handy for uploading during Registration.
- Applicant shall keep their Certificates, Mark sheets & other documents ready as per Clause-7 of the advertisement while filling in the details of the educational qualification & other claims during filing of Online Application Form.
- Applicants should enter the Aadhar number in the appropriate field in the online application form.

- f. Candidates need to submit detail information of online Caste Certificate issued by competent Authority in the online application form. But if the valid online Caste Certificate issued by the competent Authority is not in possession with the candidate at the time of submission of the online application form, he/she must give self declaration in the format appended to the online application form.
- g. Candidate claiming reservation/age relaxation under “**Ex-Serviceman**” category need to upload any one of the Ex-Servicemen Documents i.e. **Discharge Certificate/ Identity card/ PPO (wherein the date of entry, date of discharge and period of service rendered in Defence Forces have been reflected)**. Ex-Servicemen who are going to retire within six months from the closing date of online application may apply for the post by obtaining relevant “No Objection Certificate” from the appropriate authority mentioning therein the date of appointment, date of retirement and years of service rendered in Defence Forces. However such candidates have to submit the discharge certificate on the date of certificate verification on the date of certificate verification for considering their claims under Ex-Serviceman category.

The scanned document must be in “Pdf” format between ranges of 100kb to 500 kb.

- h. candidates claiming reservation/ age relaxation under “**PwD (Persons with Disabilities)**” category need to upload a valid online PwD certificate showing disability of 40% or more of permanent nature in the benchmark disability of Hearing Impairment(HI) issued by **Unique Disability Identification (UDID)/Competent Authority**. The scanned document must be in “Pdf” format between ranges of 100kb to 500 kb.
- i. **In-service contractual employees of Government Offices** claiming age relaxation (maximum age limit 45 years as on 01.01.2021) as per Govt. in G.A. Department Notification No.GAD-SC-Rules-0061-2013-1147/Gen dtd.17.01.2014 if the candidate is in Group-B Post & Notification No.GADSC-Rules-0009-2013/32010/Gen dtd.18.11.2013 and who have completed minimum one year of continuous service prior to commencement of Odisha Group- B/ Group-C& D posts Contractual Appointment Rules, 2013 must possess the required certificate issued by the concerned employer in the proforma prescribed by the Commission vide Advisory Notice No.3568/OSSC dated 01.11.2019 available in the website of the Commission [www.osscc.gov.in](http://www.osscc.gov.in). They shall have to fill the detail information like Name of the Employer, Scheme of appointment, date of appointment, whether covered under Category-I/Category-II (as per clause-8 of Odisha Group-B/Group-C & D Contractual Appointment Rules-2013), FD Approval/Concurrence No. in the online application form and candidate has to produce the originals during Certificate Verification for consideration of his/her claim under Contractual in-service benefits.



The candidate should ensure that the scanned Photograph and full Signature, Left/Right Hand Thumb Impression and other relevant documents must be clearly identifiable/ visible, otherwise the registration and application shall be liable for rejection and no correspondence on this account shall be entertained.

Candidates must submit correct data /information in the Online Application Form basing on which the candidate shall be allowed to appear the examination. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria prescribed for the post, his/her candidature for the post will be cancelled forthwith.

**4. Vacancies to be filled up and reservations:**

4. (b) PwD candidates having disability of 40% or more in the Benchmark Disability of Hearing Impairment (Category-II) with suitable aid are eligible to apply for the posts by availing age relaxation.

**NOTE: Vacancy position is subject to change as per discretion of the Requisitioning Authority/Government.**

4. (c) The number of vacant posts to be filled up on the basis of this recruitment is subject to change without any prior notice as per discretion of the Commission the Requisitioning Authority and Government.

**5. Remuneration & Condition of Service:-**

The appointment to these posts will be as Initially Appointee carrying a remuneration of Rs.25300/- per month (for 1<sup>st</sup> year) as per Govt. in G.A. & P.G. Department Notification No.19569/Gen. Dtd. 12<sup>th</sup> Sept. 2017 & Notification No.28626/Gen dtd.27.10.2021 and Condition of Service will be guided by the Odisha Group-B Posts (Contractual Appointment) Rules, 2013 notified vide Govt. in G.A. Department Notification No: GAD-SC-Rules-0061-2013-1147/Gen dt.17-01-14 and the relevant recruitment Rule.

6. **Eligibility:**

6. a. **Age:**

- i. Since the vacancies are meant for SC & ST, the minimum age for the post is 20 years and the maximum age is 37 years as on 01.01.2021. The upper age limit is relaxable by 10 years for candidates belonging to PwD category & the total period of service rendered in Defence Services(beyond 32 years as on 01.01.2021) in case of Ex-servicemen. **(To be eligible, candidates must not have been born earlier than 2<sup>nd</sup> January, 1984 and not later than 1<sup>st</sup> January 2001).**
- ii. A candidate can only avail one type of age relaxation as per rule.
- iii. The persons in Defence Forces having more than six months to retire/ discharge from the forces as on the last date of the submission of online application are not eligible to apply as ex-serviceman for the post. The Ex-Servicemen who are going to retire within six months from the closing date of online application may apply for the post by obtaining relevant **no objection certificate** from the appropriate authority mentioning therein the date of appointment, date of retirement and years of service rendered in Defence Forces. However such candidates have to submit the discharge certificate on the date of certificate verification for considering their claims of age relaxation under Ex-Serviceman category.

**Border Security Force, Indian Coast Guard, CRPF and other Para Military Forces are not within the definition of Ex-Servicemen.**

The upper age limit is relaxable for in-service contractual employees engaged by the Govt. or through manpower service provider agencies in the State Govt. offices or in the State Govt. of Odisha who have completed at least one year of continuous service prior to commencement of "Odisha (Contractual appointment) Rules-2013". They must be less than 45 years as on 01.01.2021. They should submit the required proof from their employer for availing age relaxation and upload the required document.

- 6.(b). Date of birth entered in the High School Certificate Examination by the Board of Secondary Education, Odisha or equivalent Certificate issued by the recognised Board/Council /by an Indian University as equivalent there to shall only be acceptable to the Commission.


6. (c) **Educational Qualification:**

The candidate must have passed Diploma in Handloom Technology/ Textile Technology from IIHT or other Government recognized Institutions as per the list given in Annexure-‘A’.

6.(d) **General Eligibility Criteria**

In order to be eligible for appearing in the examination a candidate must satisfy the following conditions.

- i. The candidate must be a citizen of India.
- ii. Be able to speak, read & write Odia.




- iii. Be of good moral character & conduct.
- iv. Be of good mental condition and bodily health and free from any physical defect likely to interfere with the discharge of his duties in the service.
- v. If married, must not have more than one spouse living. Provided that Government may, if satisfied that such marriage is permissible under Personal Law applicable to such person or there are other grounds for doing so, exempt any person from the operation of this rule.
- vi. Candidate must have passed Middle School Examination with Odia as a language subject, or have passed High School Certificate Examination or equivalent examination with Odia as a subject/medium of examination in non-Language subject, or have passed in Odia as a language subject in the final examination of Class VII or above or have passed a test in Odia in M.E. School Standard conducted by the School & Mass Education Department.

**Not fulfilling any of the eligibility criteria shall render the applicant's candidature invalid & rejected.**

**7. Certificates / documents to be submitted at the time of certificate verification**

The certificates/documents as listed below from (ii) to (viii) have to be submitted in original along with self-attested Xerox copies of the same and copy of the Online Application Form during certificate verification. The original documents to be submitted during certificate verification must tally with the documents uploaded by the candidate except the declaration of caste certificate. The candidates claiming reservation/age relaxation under SC/ST category must submit the valid caste certificate issued by the competent Authority to get reservation/age relaxation in the respective category.

- (i) Hard copy of the Online Application Form.
- (ii) HSC or equivalent pass certificate & mark sheet issued by any recognised Board/Council.
- (iii) Diploma in Handloom Technology/ Textile Technology pass Certificate & Mark sheet
- (iv) Valid ST/SC caste certificate issued by competent authority.
- (v) Candidates have to submit certificate of passing HSC examination with Odia as a compulsory subject, or in lieu thereof a certificate of passing a language test in Odia in final examination of Class-VII issued by Principal/Head Master or any Educational Institution duly recognised by Govt. of Odisha/ Central Govt. or other competent authority.
- (vi) Disability (UDID) certificate (shall be in permanent nature and disability not below 40%) issued by UDID authority.
- (vii) Candidates claiming Ex-Serviceman/age relaxation under Ex-servicemen category must submit Discharge certificate/ identity Card / P.P.O issued by the appropriate Authority indicating there in the Date of Entry, Date of Discharge & Period of Service rendered in Defence forces.



(viii) In-Service contractual employees claiming age relaxation and contractual In-service benefits must submit a Certificate from employer in the proforma prescribed by the Commission vide the **Advisory Notice No.3568/OSSC dated 01.11.2019** available in the website of the Commission [www.oss.gov.in](http://www.oss.gov.in).

**8. Plan of Examination:**

(i) The plan, pattern, scheme and syllabus of Examination is suggested as follows:-

The recruitment to this post will comprise of two stages

1. Written Examination, and 2. Certificate verification

Candidates numbering three times of the vacancies will be shortlisted in order of merit, category wise basing on their performance in written examination.

**There shall be no viva-voce test.**

**Written Examination will comprise of two papers.**

**Paper-I**

(a) **Composite paper**

**English & Odia Language Test: (15 marks each)**

Active and Passive Voice, Sentence Structure, Direct & Indirect speech, Pronouns, Prepositions, Antonyms & synonym, correction of common error Sandhi & Samas. The questions on General English & Odia Language will be of HSC standard and will comprise of comprehension of given passage, vocabulary & usage & grammar.

- **Computer fundamentals (10 marks)**

MS Window

MS Office, MS Word, MS Power Point,

MS Excel & MS Access.

- **General Awareness (30 marks)**

The questions of General awareness will comprise of questions on Indian History & History of Odisha, Geography of the world and of India, Indian Polity, Environmental studies, Human rights, Socio Economic Development, Art & Culture & General Science. The questions will be of HSC standard.

- **Mental Ability & Reasoning (30 marks)**

The questions of Mental ability & reasoning will comprise of questions on Analogy, Classification, Series, Coding-Decoding, Blood Relations, Direction Sense Test, Logical Venn Diagrams, Alphabet Test, Sitting Arrangements, Mathematical Operations, Arithmetical Reasoning, Inserting the Missing Character, Number, Ranking and Time Sequence Test, Eligibility Test, Syllogism, Statement and Arguments, Statement and Assumptions, Statement and Courses of Action, Statement and Conclusions, Deriving Conclusion, Assertion and Reason, Situation reaction Tests, Analytical Reasoning.


**1. Fibre Science** – Classification, Manufacturing, Properties, Uses and Identification of both Natural & Synthetic Fibres, Melt. Wet and Dry Spinning.

**2. Yarn Manufacture** – Objectives and Mechanism of Ginning, Carding, Drawing, Doubling, Drafting, Combing and Compact Spinning. Machineries used and their functions, maintenance of Machineries, Yarn defects with remedial measures.

**3. Fabric Manufacture** – Objectives of Warp & Weft Winding, Types, Features & Mechanism of Different Winding Machines, Fabric Defects and remedial measures, Sizing, Parts of different looms and their functions with working principles, Fabric Designs. Drafting, Lifting and Denting.

**4. Textile Chemical Processing** - Objectives of various pre-treatment like Singeing, Desizing, Sourcing, Bleaching, Mercerizing and their Methodologies using different machineries, Classification of Dyestuffs, Dyeing & Printing, Dyeing Recipes, Working Principles of Dyeing Machineries, Colour Fastness, Printing Pastes, Different Finishes like Calendaring, Heat Setting, Anti Crease, Water Proof, Flame Retardant, Softening, Stiffening, Moth Proof, Optical Whitening, Antimicrobial.

**5. Textile testing** – Factors influencing Testing of Fibre, Yarn and Fabric, Fibre, Yarn and Fabric, Quality, Principle of Testing, Air & Water Permeability, tensile, Tearing, Bursting Strength, Evenness, Fibre Maturity, Impurities, Abrasion Resistance and Pilling, Machineries used in Textile Testing and their functions.





- Note: 1. **There will be negative marking (0.25 marks) for each wrong answer in both Paper-I & Paper-II.**
2. **Candidate who will fail to appear in any stage of examination shall not be allowed to appear in subsequent stages of examination.**

**There shall be no Viva-Voce Test.**

**9.Certificate/Document verification -**

**Candidates numbering about 3(three) times of vacancy, in order of merit, category wise shall be shortlisted basing on the sum total of marks secured in Paper-I and Paper-II taken together for Certificate/Document Verification to determine their eligibility for the post with reference to their original certificates. The candidature of the candidates will be rejected who will fail to appear in certificate verification on the date notified.**

**10.Place, Date, Venue of Examination/certificate verification & Admission Letter**

The Date, Time, Venue of the Computer Based Recruitment Examination (CBRE) will be informed to the candidates in the Admission Letter, which will be made available in the website of the Commission. The Admission Letter will be carrying the photograph and signature of the candidate and facsimile signature of Secretary of the Commission. The Admission Letter will also contain instructions to the candidates which should be followed strictly by the candidates. Any deviation made by the candidate during the examination will forfeit his/her candidature for the post. The Admission Letters will be made available in the official website of the Commission prior to the holding of the CBRE. The candidates shall have to download the admission letters by accessing the Commission's website and using their 'User ID' and 'Password' to appear the CBRE. The date of the CBRE will be informed to candidates by publishing Notice in the Commission's website & also in newspapers. Alert message will be sent to the candidates through their registered Mobile Number/ e-mail Id. while the Admission Letters is made available in the Commission's website. Candidates are therefore advised to keep their e-Mail Id and Mobile number active till completion of the recruitment process. Each candidate shall have to download his/her Admission Letters well before the date of the examination. The candidates are also advised to regularly visit the website of the Commission to know the status of examination etc. No Admission letter will be sent through post.

**11.Select list:**

The Merit list of the candidates who found suitable in certificate verification shall be prepared basing on the sum total of marks secured in the Main Written Examination i.e. taking in to account the sum total of marks secured in paper-I & paper-II together. The select list in order of merit category wise shall be prepared from the respective Merit list which will be equal to the number of vacancies notified in the advertisement.
